# **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW. YOU MUST BE A REGISTERED USER OF THE SLOPES® APP (FREE TO SIGN UP).

## **ELIGIBILITY:**

Slopes "Join the Slopes team in Japan" Challenge (the "Sweepstakes") begins on October 1, 2024 at 12:01 a.m. in participant's local time zone and ends on December 31, 2024 at 11:59 p.m. in participant's local time zone ("Promotion Period"). The time shall be determined by Organizer's timekeeping systems. Organizer shall have the sole discretion in determining the timeliness of any action or inaction related to this Sweepstakes. All times mentioned in these Official Rules shall be Mountain Time unless expressly noted otherwise.

The Sweepstakes is open to (i) legal residents of the US (including D.C.); and (ii) who are at least eighteen (18) years old and the age of majority in their jurisdictions of residence as of the date of entry. Void where prohibited.

Employees of Breakpoint Studio LLC ("Organizer"), and each of their parent companies, subsidiaries, affiliates, advertising agencies, public relations agencies, prize suppliers, including any vendors providing services in connection with this Sweepstakes (including, without limitation partner resorts) (collectively, the "Organizer Affiliates"), and employees, agents, directors, officers (including members of their immediate family – i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren – or those living in the same household) of Organizer or any Organizer Affiliates are not eligible to participate in the Sweepstakes. TO ENTER: There are two (2) methods of entry: (i) tracking the number of days logged recording snow sports activities with the Slopes App on iPhone, Apple Watch or Android devices; or (ii) mail-in entry.

# **Slopes App**

To enter the Sweepstakes via the Slopes App, complete the following steps during the Promotion Period:

- 1. Sign into the Slopes App.

- 3. Record and save your snow sports activities with the Slopes App during the Promotion Period. Activities imported from other apps are not eligible and will not be considered valid entries. Only activities recorded with the Slopes App are considered valid entries.
- 4. Each day saved results in one (1) entry into the Sweepstakes drawing.

# Mail-in Entry

- 1. To enter without tracking days on the mountain(s) in the Slopes App, send a 3" x 5" card or piece of paper hand-written with your complete name, address (no P.O. Boxes), city, state, zip code, birth date, email address and daytime and evening phone numbers (with area code), and physical proof (Proof of Date) of being present at a ski resort on a specific day during the Promotion Period, in a self-addressed stamped envelope. # PRIZES:

The verified winner will receive the following prize:

 A prize package for one (1) winner and one (1) guest to join the Slopes team trip to Hakuba Valley, Japan (Slopes Trip) during the period February 23, 2025 to March 1, 2025, including:

- Return flights for the winner and (1) guest from an airport in the nearest city to winner's residence (as determined in the Organizer's sole discretion) to Tokyo and transfer from/to Tokyo to Hakuba Valley.
